Waiver and Release of Liability

(non-member guest only)

Acknowledges and fully understands that each club member will be engaging in activities that involve risk of serious injury, including permanent disability and death, and causing severe social and economic losses which might result not only from his/her own actions, but inactions or negligence of others, the club rules, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known or not reasonably foreseeable at this time.
- 3. Assumes all risks and accepts all responsibility for the damages following such injury, permanent disability or death, even if caused, in whole or in part, by the negligence of the "releases" named below.
- 4.
